### 7. Reports:

a. Principal's Report - Edwina Thompson (See attached)

The CIWP will be added to the Principal's Report. This will be a truncated report that shares highlights, but the traditional report (5 pages) will be attached to the Minutes.

Launched new Skills Strengthening Sessions for example Executive Functioning, Note-taking, etc. The success prompted new sessions and Summer Enrichment courses. Planning the details of further enrichments to enhance SEL (Student Emotional Learning) and the academics to mitigate the loss of learning (due to the pandemic).

State Qualifiers: Wrestling state champs, Cheerleaders 2nd in the city, Sophomore Girls Basketball team.

Thankful for the partnership with community members re: FOL and the plan investing for LT.

College - opportunity to make it to the schools and/ or to provide funding for the students' endeavors.

Black History Month: BFA hosting events to celebrate the positive accomplishments of Black Americans. This inspired other groups.

**CIWP -** Continuous Work Improvement Plan (see attached)

The current CIWP (2-year cycle) is extended through 2023 - CIWP is to revisit, make updates, or add strategies to ensure we monitor the priorities that were previously set. Three areas of focus: Instruction, Balanced Assessment / Grading, Relational Trust. The course teams - teacher to teacher, admin, and small committee collaboration goals are to maintain consistent messaging regarding grading floors, resubmissions policies, retake policies - what would work for students.

2nd page: Instruction - Action Steps: Highlighted in green: finished (i.e. master schedules). Highlighted in yellow: ongoing, such as PD (professional development). The evaluation stage includes a member of the LSC and Friend of Lane, sometime in March.

CIWP is directly tied to the LT budget (62K building operations). The money relates to the priorities set on LT CIWP. Almost all of the budget goes to staffing (Student Based Budgeting-SBB). Programs such as tutoring and funding for sports come from Internal Funds and our donors such as FOL or the Alumni Association. The Moving Forward Grant has been renewed to further support SAT prep for expanded tutoring.

CPS Budget and training process begins in March.

- 1. Instruction
- 2. Balanced Assessment and Grading
- 3. Multi-tiered systems of Support: Relational Trust

Competency A: Champions teachers and staff excellence through a focus on continuous improvement to develop and achieve the vision of high expectations for all students.

- Principal Thompson and Assistant Principal Mollie Hart met with new teachers for a lesson reflection and application of Instructional Question #1- What do you want students to learn today?
- The Grading for Equity team is working on our 3rd Professional Development presentation; we
  are currently examining the change of GPAs over time as we have implemented more
  equitable grading practices and will be focusing on the positive work being done across our
  building
- The Director of Curriculum and Instruction collected survey data from students regarding future Skills Strengthening Sessions; students are looking for help with executive functioning skills. I have already reached out to several teachers regarding holding additional sessions regarding skills time management, note-taking, and many others.
- Math, world language, and music are organizing auditions/placement exams
- Cut reports provided for specific teachers and class periods regarding attendance records.
- The Director of Culture and Climate is hosting yearly focus groups to monitor the culture and climate of our school.
- The Student Advisory Committee designed an advisory lesson celebrating Black History Month and bringing awareness to disparities in the Black community
- The Curriculum and Instruction committee collected ideas regarding how lessons and units could be updated to be more culturally relevant while ensuring that necessary skills are also taught. These ideas are going to be utilized in our brainstorming session in which each teacher will begin planning PD for the departments or teams we represent: math, art, physics, Spanish, English. These PDs will be a joint effort between those teachers and the chairs of this committee.
- The Director of Curriculum and Instruction held a conference for new teachers who expressed concerns regarding their observations. We discussed how the observation rubric serves students and in what aspects the teachers' lessons would also meet the needs of students.
- Cluster teachers participated in biweekly collaboration meetings with teachers and SECAs
- Lane Tech Academic Center Teachers participate in weekly 7th and 8th grade team meetings to discuss instruction.
- Students of the Quarter Award are provided for our Lane Tech Academic Center students

## Competency B: Creates powerful professional learning systems to guarantee learning for all students.

- Twenty-three Alpha students have submitted their papers and/or presentations for judging at the Regional science fair. Their projects will be presented to a wider pool of STEM professional judges. Awards will be announced on 2/24.
- Assistant Principal Joshua Dresser hosted an Aspen Journal PD Session for staff in order to
  foster transparency and information sharing about communication to students and families.
   Since the PD, we have logged over 250 contacts to Lane families about attendance, academics,
  or other concerns.
- The advisory committee held student-led workshops and videos to support advisory lessons; they are created to ensure that teachers feel prepared to have conversations.
- Admin/counselors/service providers met with SOT/FOT students with IEPs to create next steps plan to get them back on track
- SOT/FOT to begin Academic Academy support after school with a counselor. Students have already been meeting with individual counselors for check-ins.

- Teachers and Administration will represent Lane Tech and CPS at the College Board's Preparate and A Dream Deferred conferences in New York City and Washington DC to further our study of diversity and equity at Lane Tech and in the district.
- The Skills Strengthening Sessions were successful in that students who had not pre-registered showed up to classes, and over 93% of students who filled out the survey indicated that they would utilize some or all of what they learned in the session; of those same students, 83.8% indicated that they would attend a follow up session on the Skills Session that they had covered. Students' reasoning for their answers included what they found helpful: the instructor and instructors' explanations, the resources provided, and the opportunity to practice with the class. Utilizing this data, the Director of Curriculum and Instruction will work with teachers to plan our next set of sessions to take place in April.
- ACCESS and DLM assessments are ongoing for ELL and cluster students
- TA and Senior Leader History Fair tutoring workshops during Advisory days
- The Admin, Working alongside Counselor Blanton-Morgan on grading practices to help support students with chronic absences
- The Culture and Climate Team continues to meet weekly to support the needs of students
- The Social Workers are taking referrals for support groups

## Competency C: Builds a culture focused on College and Career readiness-develops the full range of students' learning capacities, creative, social-emotional, behavioral and physical.

- IHSA All Academic Nominations: Maggie Zehr and Michael Molloy are the Lane Tech nominees for this prestigious award. Students must have a 3.5 cumulative GPA or higher after 7 semesters to qualify among being a good citizen and participating in two IHSA sports seasons.
- Opportunities for restorative conversations and relationship building skills are taught when addressing student to student conflict or teacher to student conflict.
- School counselors and the college and career coach led junior college lessons during physics classes (with additional sessions during lunches, after school, and during advisory) to ensure juniors understand the basics of the college application process and how to use Naviance.
- 96.14% of non-cluster Lane seniors have applied to at least one college. 85.7% of non-cluster seniors have applied to at least three colleges. Lane seniors have completed 7,905 college applications.
- 60.87% of seniors have reported a college acceptance in Naviance.
- Our College and Career Center hosted Lurie Childrens' hospital's workforce development team, CPS' Chicago Police and Fire Training Academy, The Fellowship Initiative, Northwestern Academy for CPS, Bottom Line Chicago, and Chicago Scholars to present about their programming for Lane students.
- The College and Career center hosted our first Lunch with a Professional of the school year, featuring Ilyssa Fradin, a SAG-AFTRA professional Actor in Chicago. This Friday Jim Barrios, a senior software engineer at Chicago Trading Company will join our students virtually for Lunch with a Professional.
- Approximately 20 students received 1:1 support from Eric Nava from NEIU/ Wright College's Caminos Al Exito grant, which supports students at select northside schools in applying to college.

- The College and Career Center scheduled a field trip to Truman College for students to learn about the cosmetology, automotive technology, and Teach Chicago Tomorrow program for March 10th. We recruited students interested in alternative pathways to attend a presentation on YearUp Chicago later in February. YearUp is a one year job training program that helps low income students become IT support specialists, data analysts, project managers, and sales support individuals. Requested spots for fifty students to attend CPS' upcoming skilled trades fair in late March.
- SAT Prep Session 1 is nearing its end, and Session 2 will begin shortly. We have already put in place a system that emails students important information that they need regarding their classroom number, teachers' names, course title, and attendance. This was in response to students reporting that they did not know where to go with our previous system, as we feel that it helps alleviate some of the confusion and stress for them.
- Case managers monitored statuses of College Board requests submitted in January 2022. As of 2/11/2022, 447 Lane students are approved for testing accommodations for upcoming PSAT, SAT and AP exams. Nine students' requests are pending approval.
- Counselors solicited student recommendations for small group anxiety focus groups
- Our LTAC Academy Focus is history fair and time management amidst a new semester
- Our Director of Grading and Assessment has begun planning for the SAT, PSAT, IAR, Seal of Biliteracy, ISA, and AP assessments to be given between March and May

### Competency D: Empowers and motivates families and the community to become engaged.

- Principal Thompson meets monthly with the Friends of Lane to engage with parents about our school's process. This month we presented "The State of Lane"
- Principal Thompson submits weekly communications to parents, staff and students to update them about Lane's accomplishments and policy information
- The Lane Tech Alumni Association sponsored our Robotics Team equipment to ensure participation in their competitions this season
- Staff and community partners are creating opportunities to address supportive events for all of our students. A prom dress drive is being planned for those students who would like to participate.
- Our Counselors and College and Career Coach hosted junior parent night for approximately 300 junior parents and provided instructions on using Google Meet's live translation to ensure Spanish speakers could engage with the presentation.
- Lane's annual college fair is a 3-day virtual event filled with college panels, including a panel in Spanish.
- SAT Prep Session 1 has successfully reached the third week, and we have implemented a
  system for attendance that allows parents and guardians to monitor their child's attendance to
  the classes each week. This has allowed more communication with families regarding
  students' attendance.
- English Language Program Teacher continues to host meetings for BAC in an effort to establish a committee to support English language learners at at Lane

Competency E: Relentlessly pursues self-disciplined thinking and action supports a climate that values, accepts, and understands diversity in culture and point of view.

- The Black Student Association has hosted a variety of activities each week to celebrate the history and accomplishments of African Americans throughout time.
- Women in Literature students hosted their annual Women in Literature Festival to examine the triumphs and trials of women throughout time.
- Alpha STEM Research started the 2nd semester by discussing ethics and bioethics by way of reading the book, The Immortal Life of Henrietta Lacks. Their culminating essay will focus them on applying ethical considerations in their future fields of STEM, focusing on empathy and compassion as they move forward in their STEM careers.
- Principal Thompson meets quarterly with various representatives from student leadership to hear what is going well and where we need to improve.
- Perfect attendance certificates were provided to 937 students!
- Focus Groups ,peer conference, advisory, prom dress drive and BIPOC committees continue to meet to address student concerns and progress

- ILT provides guidance and examples of rigorous learning targets and coaches teachers on how to scaffold and provide appropriate feedback for those learning targets
- **Provide PD on analyzing data in gaps in essential knowledge** in order to bridge the formative and summative assessments
- Create course team policies regarding retake and resubmission policies

To the Chicago Board of Education and Chief Executive Officer Martinez:

We are writing to express our concern about the negative impact on teaching and student voice caused by the CPS implementation of the Student Online Personal Protection Act (SOPPA). We support the critical importance of student data privacy provided by SOPPA, but CPS is simply taking too long to process the legal compliance of key software tools. we are already half way through the school year and key tools are still either unavailable or "in process" churning through the CPS compliance bureaucracy while other public schools in Illinois are using hundreds of different applications and sites in full compliance with SOPPA.

Lane Tech High School's recent adoption of one-to-one technology, educational **software is** more key than ever to the student and teacher experience at our school. Currently, Lane teachers are prohibited from using the best available tools and curriculum that are being used at other large high schools in Illinois. We are asking CPS to stop depriving students and teachers of access to much-needed software. The goals of privacy and access to educational technology need not be at odds!

Specifically, Lane Tech is seeking immediate access to the following educational tools:

- 1) Code.org status listed as "in process" on CPS website. Why wasn't this on the last board agenda?
- **2) Khan Academy st**atus listed as "in-process" on CPS website. Why wasn't this on the last board agenda?
- **3) Student News Online (SNO)** Recently approved CPS vendor #279844, but for some reason they were not approved for the latest SOPPA compliance approvals? Why? They

have SOPPPA compliance with other school districts in the country.

- **4) Scratch.MIT.edu -** Is a valuable coding learning tool created by MIT. Not listed on CPS website.
- **5) Quest** is a tool for Physics created by UT Austin and is instrumental in the learning experience of physics students. Quest is designed for college level students. Can the Lane Physics department use this tool since it is not designed for K-12 students? So it should not require SOPPA approval, right?

While we understand the significant legal contractual component to the SOPPA compliance for a district as large as CPS, we urge CPS to streamline its SOPPA compliance approval process. Approvals should **not have to wait f**or a monthly board meeting as any delay is yet more time students are deprived in the **classroom**. A month or five months may not seem like a long delay to the central office or the board, but it translates to a meaningful disruption to the school year for teachers and students. In short, there are solutions at hand to speed up the SOPPA compliance of key software that Lane Tech students need to fulfill a well-rounded and equitable education **experience in our classrooms**.
